The Dramatic Impact

- The tariffs impacted 300,000+ businesses that imported goods from around the world
- The tariffs had an effect on the cost of industries like food, tires, textiles, auto, electronics, construction, and retail sales.
- The tariffs created financial distress on many companies.
- And even drove some companies out of business.
- A broader effect was the increase of prices on the US consumer goods, called inflation.
- Why? Because companies pass their added expenses on to the consumer so their bottom lines will remain in the positive.

Supreme Court Decision

February 20, 2026



- The legal action over these tariffs began with 3 companies.
- Almost overnight it became a class action lawsuit that involved 100+ companies and dominated the news for months.
- This is the date when the Supreme Court ruled that these tariffs were not legal, and that they must be repaid with interest.
- This ruling produced a mad dash by companies to file and receive their refunds.

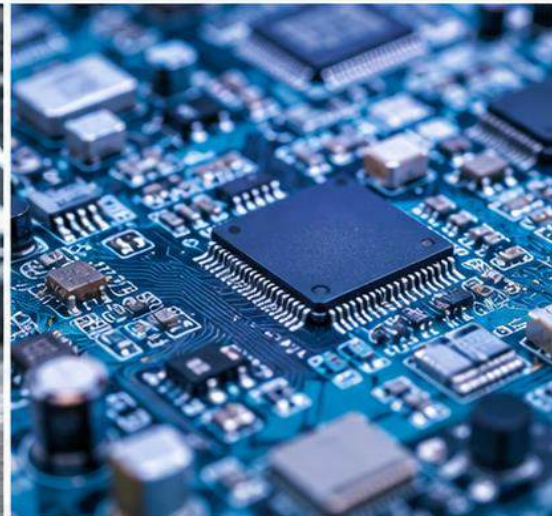

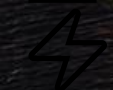
